### GUIDE AT-A-GLANCE: Why and How?



This Reading Reflection Guide is intended to create a deeper understanding of important underpinnings related to the Equitable Evaluation Framework™ and a shared base for exploration and discussion. It includes readings, followed by questions to spark reflection and advance learning and action. This particular Guide is primarily intended for foundations, but others (evaluators, consultants) may find it useful as well. A few things:

- These concepts stem from a Western frame (e.g., North American, cisgender male, white). We invite and encourage identification of additional readings that will push us to expand our understanding and definitions (e.g., Indigenous, etc.).
- This Guide can be used in different ways and for varying purposes, however most useful, particularly in support of making the case, toward equipping for transformation and Equitable Evaluation principle adoption. This might include personal reflection (e.g., journaling), team discussion (e.g., retreats), staff training (e.g., onboarding), capacity building (e.g., lunch and learns), outreach (e.g., webinars), and/or more.

#### READING MATERIALS



These readings offer history, context and insights around the ways in evaluation, philanthropy and equity are in relationship (or not) to each other. Expanding our understanding and approaches can build greater confidence in findings and paint a more complete, meaningful, and accurate picture of the complex world in which we live.

#### What's Race Got to Do with It? Equity and Philanthropic Evaluation Practice

This paper offers an overview of the origins of evaluation and the implications of those origins given 21st century complexity and increasing recognition of the role of race in framing much of what we believe to be true and valid. (Winter 2019)

#### **Evaluation and the Framing of Race**

Authored by Dr. Ernie House, this provocative piece reflects on his own racial framing and its history. House is an American academic specializing in program evaluation and education policy. His recent writings speak to the hidden bias in evaluation practice and ask that evaluators explore the ways in which white racial framing has created the evaluation we predominantly practice in the United States. #### **Equitable Evaluation Framing Paper**

This framing paper is a product of the Equitable Evaluation Project (now the Equitable Evaluation Initiative) and was published in July 2017. Its original intent was to set the stage for an invitational roundtable in August 2017 where findings and implications and potential next steps were explored focusing primarily on philanthropic domestic evaluation practices.
